Dear Director of Guidance/Counseling:

At **Island Federal Credit Union**, we recognize the growing cost of higher education. That's why Island FCU, one of Long Island's leading credit unions, is offering **\$1,000** awards to **20 local high school seniors** in 2009. Over the past 16 years, Island FCU has given out more than \$210,000 in scholarships to help local students continue their education beyond high school.

In order to be fair and equitable to all entries, the scholarships will be awarded through a random drawing among all entry forms that Island FCU receives by **Friday, May 29, 2009**. This is how to enter:

- A student should complete one entry. Entries are available at all three Island branches (located in Hicksville, Hauppauge or Sayville) or can be downloaded from our website www.islandfcu.org. Only current seniors are eligible.
- The student must be a member of Island FCU to enter, however, *there is absolutely no cost or other obligation on their part*. If the student is not already a member of Island FCU, they can join simply by opening an account at any branch in minutes. It costs nothing; in fact, *we will deposit the first \$5 to open a savings account*. They should bring appropriate ID and their Social Security number to prove their identity.
- The completed entry should be sent to Island Federal Credit Union so that we receive it by **Friday, May 29, 2009**.
- The students selected must submit proof that they have been accepted for full-time study at a University, College, Community College or a vocational school in order to be eligible for the award.

The drawing will be held on **Friday, June 5, 2009**. We will contact the winners by mail. Island FCU will publish the complete list of winners in the *Island Quarterly* newsletter and post the names at all branches.

We greatly appreciate your help in getting the word out to your seniors and their parents. At Island Federal Credit Union, we are making this significant contribution as part of our ongoing commitment to serve our local communities. ISLAND FEDERAL CREDIT UNION TO AWARD TWENTY \$1,000 SCHOLARSHIPS

Island Federal Credit Union will award a \$1,000 scholarship to **twenty (20)** high school seniors planning to continue their education. To be eligible, students must:

- ✓ Be a Primary Member¹ in good standing at Island Federal Credit Union. The account must be established in the student's name at the time the entry form is submitted.
- ✓ Be a High School Senior at the time the entry form is submitted.
- ✓ Have received acceptance into a full-time course of undergraduate study as a Freshman at a University, College, Community College, or recognized vocational school. *(If selected, you will be required to provide proof of acceptance into the school you will be attending.)*

To enter, download and fill out the application on our website www.islandfcu.org or complete this form and return it to Island FCU no later than Friday, May 29, 2009. Twenty (20) names will be randomly drawn on Friday, June 5, 2009. All winners will be notified via mail and a list of recipients will be published² in the *Island Quarterly* newsletter, as well as displayed in our branch offices.

¹ Membership in Island FCU is open to anyone who lives, works, worships or attends school in Nassau County or Suffolk County with the exception of the townships of East Hampton, Southampton and Shelter Island.

² Acceptance of the Scholarship shall constitute winner's consent to use by ISLAND FEDERAL CREDIT UNION of winner's name and photograph for advertising and promotional purposes without further compensation.

* IFCU Officials, Employees, Volunteers and their family members are not eligible to enter.
