TAX LEVY THRESHOLD YEAR 5

- ☐ The allowable levy growth factor is the *lesser* of 2% or CPI.
- ☐ For the 16-17 budget, the CPI, which will be used for the tax levy threshold calculation before exclusions will be 0.12%.
- For the 16-17 budget, the tax base growth factor for Jericho (provided by the NYS Office of Real Property) is 0.62%.
- Accordingly, Jericho's tax levy threshold for 16-17 is 0.44%, and our goal is to achieve a 0% tax levy for 16-17 while securing all instructional programs.

POSITIVE OUTLOOK



- NYS Mandated Employer Contribution Rates to the Employee Retirement System (ERS) will decrease for 16-17.
- NYS Mandated Employer Contribution Rates to the Teachers Retirement System (TRS) will also decrease for 16-17.

Challenges



- Health insurance premiums for 2016 will increase over 7% for the NYSHIP plan (the highest increase in the past few years). How will the continued rollout of the Affordable Care Act legislation affect future NYSHIP premiums?
- What is the potential impact of the unilateral removal by the Nassau County Department of Assessment of LIPA properties from all Nassau County tax rolls? The 15-16 reduction amount for Jericho School District is \$2.4M.
- **□** While TRS/ERS contributions will be lower in 16-17, how will the recent stock market volatility impact future rates?

CAPITAL RECOMMENDATION PROPOSITION #2



SHALL the Board of Education be authorized to expend a sum not to exceed \$16,306,125 as shall the Board of Education be authorized to expend a sum not to exceed \$16,306,125 as follows (1) \$10,000,000 plus interest from the capital reserve fund established on May 21, 2013 and (2) \$6,306,125 from fund balance for the purpose of completing capital improvements as follows: District-wide masonry renovations, District-wide ADA compliance upgrades, District-wide PA and clock system upgrades, District-wide fire alarm and smoke/heat detection upgrades, District-wide security and security mantrap upgrades, District-wide water distribution system upgrades, District-wide door replacement, District-wide asbestos abatement, District-wide ceiling/lighting upgrades, District-wide interior wall renovations, District-wide air handling and ventilation equipment upgrades, District-wide sidewalk and pavement renovations, generator upgrades at Jackson, Saaman, and Cantingua Elementary, Schools, and the transportation facility upgrades at Jackson, Seaman, and Cantiague Elementary Schools, and the transportation facility, roof replacement (including skylights) at Seaman and Williams Elementary Schools and the transportation facility, swimming pool renovations at Jericho High/Middle School, renovation of Little Theatre at Jericho High/Middle School, renovation of science labs at Jericho High/Middle School, auditorium upgrades at Cantiague Elementary School, air handling and classroom ventilation upgrades at Jericho High/Middle School, boiler replacement at Williams Elementary School, installation of pre-fabricated metal commercial building at the transportation facility; construction of work/storage building at the maintenance facility, all of the above to include all labor, materials, equipment, apparatus, and incidental costs associated therewith labor, materials, equipment, apparatus, and incidental costs associated therewith.

WHY DO WE NEED A FUND BALANCE AND WHAT IS ITS VALUE?



- To assure the public that the budget plan will tolerate a certain amount of unexpected adversity without forcing a crisis.
- To meet unanticipated expenses and to provide for "rainy day" emergencies.
- To provide options for long-term planning (e.g. Capital Reserve).
- A stable fund balance is an indicator of good money management, and assists in stabilizing taxes during this tax cap era.
- A stable fund balance results in a good credit rating, which leads to lower interest costs for long and short-term borrowing.
- Managing fund balances is one of the most difficult tasks of the budgeting process, since budgets are only <u>estimates</u> of expenditures and anticipated revenues.
